COMPETITION RULES & DISQUALIFICATIONS:

Rules:

- *Competition participants must arrive 30 minutes before the competition begins to check-in or their space will be forfeited. No refunds. Event schedule subject to change depending on the # of participants we will need to accommodate.
- Contestants will begin eating their noodles (Lo Mein noodles in sauce) at the sound of the gong. Contestants must keep their hands under the table until the gong is sounded.
- Participants can eat using their choice of chopsticks, fork or hands.
- Contestants will stand-up when they have finished all their food and a judge will ensure it is completely gone.
- The winner is the person who eats his bowl of noodles the fastest and swallows it with no food remaining in the bowl or mouth.
- A judge will perform a "tongue test" to ensure that the winning contestant has swallowed all food.
- Participants will receive one glass of water per round and one in between rounds.
- Judges will be on hand to assure adherence to contest rules. Judge's decision is final.
- Rules subject to change.

Disqualifications:

- Starting before the gong is sounded.
- Unfair or poor sportsmanship acts determined by the judge.
- Refusal to meet any contest rules stated by the judge.
