COMPETITION RULES & DISQUALIFICATIONS:

Rules:

- Competition participants must arrive 30 minutes before the competition begins to check-in or their space will be forfeited. No refunds. Event schedule subject to change depending on the # of participants we will need to accommodate.
- Contestants will begin wrestling at the sound of the gong.
- The winner of each bout is the person who wrestles their opponent off the mat.
- The winner of each bout will move on to the next round in a bracket competition format.
- There will be one winner of each weight class (petite sumo, average sumo, strong sumo)
- Participants are required to wear athletic shoes and comfortable clothes for easy and comfortable fit into the sumo costumes.
- Participants should not eat or drink before wrestling.
- Judges will be on hand to assure adherence to contest rules. Judge's decision is final.
- Rules subject to change.

Disqualifications:

- Starting before the gong is sounded.
- Unfair or poor sportsmanship acts determined by the judge.
- Refusal to meet any contest rules stated by the judge.
